#### PRIVACY POLICY

This privacy notice for Cornerblock Services Limited ("we," "us," or "Our"), describes how and why we might collect, store, use, and/or share ("process") your information when you use Our services ("Services"), such as when you:

#### Interpretation

#### **DEFINITIONS**

For the purposes of this Privacy Policy:

- I. 'Account' means a unique account created for You to access our Service or parts of our Service.
- II. 'Company' (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Cornerblock Services Limited.
- III. 'Cookies' are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.

#### **SUMMARY OF KEY POINTS**

- I. What personal information do we process? When you visit, use, or navigate our Services, we may process personal information depending on how you interact with us and the Services, the choices you make, and the products and features you use.
- II. **Do we process any sensitive personal information?** We may process sensitive personal information, when necessary, with your consent or as otherwise permitted by applicable law.
- III. Do we collect any information from third parties? We do not collect any information from third parties.

### 1. WHAT INFORMATION DO WE COLLECT?

We collect personal information that you voluntarily provide to us when you register on the Services, express an interest in obtaining information about us or Our products and Services, when you participate in activities on the Services, or otherwise when you contact us. The personal information we collect may include the following:

- Names
- Phone numbers
- Email addresses
- Home addresses
- Bank Verification Number (BVN)
- Employment details
- Salary information
- Contact preferences
- Contact data

**Sensitive Information:** When necessary, with your consent or as otherwise permitted by applicable law, we process the following categories of sensitive information:

- Financial data
- Government identifiers (e.g., National Identification Number)

All personal information that you provide to us must be true, complete, and accurate, and you must notify us of any changes to such personal information. (*NDPR 2019 Policy*)

# 2. HOW DO WE PROCESS YOUR INFORMATION?

We process your information to provide, improve, and administer Our Services, communicate with you, for security and fraud prevention, and to comply with law. We may also process your information for other purposes with your consent including:

- To facilitate account creation and authentication and otherwise manage user accounts: We may process your information so you can create and log in to your account, as well as keep your account in working order.
- To deliver and facilitate delivery of services to the user: We may process your information to provide you with the requested service.
- To respond to user inquiries/offer support to users: We may process your information to respond to your inquiries and solve any potential issues you might have with the requested service.
- To request feedback: We may process your information when necessary to request feedback and to contact you about your use of Our Services.
- To send you marketing and promotional communications: We may process the personal information you send to us for Our marketing purposes, if this is in accordance with your marketing preferences. You can opt out of Our marketing emails at any time.
- **To protect Our Services:** We may process your information as part of Our efforts to keep Our Services safe and secure, including fraud monitoring and prevention.
- To comply with Our legal obligations: We may process your information to comply with Our legal obligations, respond to legal requests, and exercise, establish, or defend Our legal rights.

### 3. DO WE USE COOKIES AND OTHER TRACKING TECHNOLOGIES?

We do not use cookies and other tracking technologies to gather information when you interact with Our Services.

#### 4. HOW LONG DO WE KEEP YOUR INFORMATION?

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements). No purpose in this notice will require us keeping your personal information for longer than the period in which users have an account with us. (NDPR 2019 Policy)

#### 5. HOW DO WE KEEP YOUR INFORMATION SAFE?

We have implemented robust and comprehensive technical and organizational security measures designed to protect the security of any personal information we process. Our security measures include encryption, firewalls, secure access controls, and regular security audits to ensure the highest level of protection for your information.

We are committed to maintaining the security of your personal information and have rigorous procedures in place to prevent unauthorized access, data breaches, and other security incidents. Our information security team continuously monitors and updates our systems to address potential vulnerabilities and respond swiftly to any threats.

- IV. <u>The right to restrict processing:</u> You have the right to request that we restrict the processing of your personal information.
- V. <u>The right to object to processing:</u> You have the right to object to the processing of your personal information for marketing purposes.
- VI. <u>The right to data portability:</u> You have the right to request that we transfer your personal information to another data controller.

### 8. DO WE MAKE UPDATES TO THIS NOTICE?

We will update this privacy notice only when there are changes in the applicable policies and laws. The updated version will be indicated by an updated "Revised" date at the top of this privacy notice. If we make material changes to this privacy notice, we may notify you either by prominently posting a notice of such changes or by directly sending you a notification. We encourage you to review this privacy notice frequently to be informed of how we are protecting your information. (NDPR 2019 Policy)
